## Coronavirus (COVID-19): Risk Assessment Action Plan, September 2021

The sole purpose of this risk assessment is to support schools in preparing for full school opening in March 2021, **whilst reducing the risk of coronavirus transmission.**

- For the purpose of this risk assessment, the term ‘coronavirus’ to refer to coronavirus disease 2019 (COVID-19).
- Schools must ensure that this risk assessment reflects the local setting and context of the school. Staff must be consulted with regard to this risk assessment.
- This should be viewed alongside relevant advice and guidance from the Department of Education and reflect any additional subsequent guidance issued to schools.

The DfE’s [operational guidance](#) for schools states that:

The government continues to manage the risk of serious illness from the spread of the virus. Step 4 marked a new phase in the government’s response to the pandemic, moving away from stringent restrictions on everyone’s day-to-day lives, towards advising people on how to protect themselves and others, alongside targeted interventions to reduce risk. As COVID-19 becomes a virus that we learn to live with, there is now an imperative to reduce the disruption to children and young people’s education - particularly given that the direct clinical risks to children are extremely low, and every adult has been offered a first vaccine and the opportunity for 2 doses by mid-September. Our priority is for you to deliver face-to-face, high-quality education to all pupils. The evidence is clear that being out of education causes significant harm to educational attainment, life chances, mental and physical health.

Spread of infection	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>• Spillages of bodily fluids, e.g. respiratory and nasal discharges, are cleaned up immediately in line with guidance, using PPE at all times.</li> <li>• Parents are informed not to bring their children to school or on the school premises if they show signs of being unwell and believe they have been exposed to coronavirus.</li> <li>• Staff and pupils do not return to school before the minimum recommended exclusion period (or the ‘self-isolation’ period) has passed, in line with national guidance.</li> <li>• Pupils who are unwell are not taken on school trips or permitted to enter public areas used for teaching, e.g. swimming pools.</li> <li>• Parents notify the school if their child has an impaired immune system or a medical condition that means they are vulnerable to infections.</li> <li>• The school in liaison with individuals’ medical professionals where necessary, reviews the needs of pupils who are vulnerable to infections.</li> <li>• Any additional provisions for pupils who are vulnerable to infections are put in place by the headteacher, in liaison with the pupil’s parents where necessary.</li> </ul>	MED		✓

Ill Health	Staff Pupils Others	Coronavirus Symptoms	<ul style="list-style-type: none"> <li>• Staff are informed of the symptoms of possible coronavirus infection, e.g. a cough, loss or change to sense of smell or taste and high temperature and are kept up-to-date with national guidance about the signs, symptoms and transmission of coronavirus.</li> <li>• Any pupil or member of staff who displays signs of being unwell, such as having a cough, fever or a loss or change to their sense of smell or taste, and believes they have been exposed to coronavirus, is immediately taken out of the class and placed in an area where they will not come into contact with others and are supervised at all times.</li> <li>• For pupils the relevant member of staff calls for emergency assistance</li> </ul>	MED		✓

			<p>immediately if pupils' symptoms worsen.</p> <ul style="list-style-type: none"> <li>• The parents of unwell pupils are informed as soon as possible of the situation by a relevant member of staff.</li> <li>• Where contact with a pupil's parents cannot be made, appropriate procedures are followed in accordance with those outlined in governmental guidance.</li> <li>• Unwell pupils who are waiting to go home are kept in an area where they can be at least two metres away from others.</li> <li>• Areas used by unwell staff and pupils who need to go home are appropriately cleaned once vacated, using a disinfectant and care to be taken when cleaning all hard surfaces.</li> <li>• If unwell pupils and staff are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection.</li> <li>• Any pupils who display signs of infection are taken home immediately, or as soon as practicable, by their parents – the parents are advised to contact NHS 111 immediately or call 999 if the pupil becomes seriously ill or their life is at risk.</li> <li>• Any members of staff who display signs of infection are sent home immediately and are advised to contact NHS 111 immediately or call 999 if they become seriously ill or their life is at risk.</li> <li>• Any medication given to ease the unwell individual's symptoms, e.g. Paracetamol, is administered in accordance with the Administering Medications Policy.</li> </ul>			
Asymptomatic testing <b>Autumn Term</b>	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>• All secondary school pupils should receive <b>2 on-site</b> lateral flow device tests, 3 to 5 days apart, on their <b>return</b> in the autumn term.</li> <li>• Settings may commence testing from 3 working days before the start of term and can stagger return of pupils across the first week to manage this.</li> <li>• Pupils should then continue to test twice weekly at home until the end of September, when this will be reviewed.</li> <li>• New intake of year 7 will be offered the 2 tests at an asymptomatic testing site (ATS) at the beginning of the autumn term when they start school.</li> <li>• Schools should also retain a small ATS on-site until further notice so they can offer testing to pupils who are unable to test themselves at home.</li> <li>• Staff should undertake twice weekly home tests whenever they are on site until the end of September when this will be reviewed.</li> </ul>	MED		✓

Positive Cases	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>Schools no longer need to do contact tracing as close contacts will be identified via NHS Test and Trace.</li> <li>School will support NHS Test and Trace when required to help identify close contacts.</li> </ul> <p><b>From 16<sup>th</sup> August 2021</b></p> <ul style="list-style-type: none"> <li>From 16 August 2021, children <b>under the age of 18 years old will no longer be required</b> to self-isolate if they are contacted by NHS Test and Trace as a close contact of a positive COVID-19 case. Instead, children will be contacted by NHS Test and Trace, informed they have been in close contact with a positive case and advised to take a PCR test.</li> <li>We would encourage all individuals to take a PCR test if advised to do so.</li> </ul> <p><b>Over 18 years of age</b></p> <ul style="list-style-type: none"> <li>18-year-olds will be treated in the same way as children <b>until 6 months after their 18th birthday</b>, to allow them the opportunity to get fully vaccinated. At which point, they will be subject to the same rules as adults and so if they choose not to get vaccinated, they will need to self-isolate if identified as a close contact.</li> <li>Continue to have a role in working with health protection teams in the case of a local outbreak. If there is an outbreak in a setting or if central government offers the area an enhanced response package, a director of public health might advise a setting to temporarily reintroduce some control measures.</li> </ul> <p><b>Staff / Students</b></p> <ul style="list-style-type: none"> <li>Staff/ students with a positive lateral flow test result should self-isolate in line with the stay at home guidance and get a PCR test to check if they have COVID-19 and continue to self-isolate.</li> <li>If the PCR test is taken within 2 days of the positive lateral flow test, and is negative, it overrides the self-test and the staff/ students can return to school as long as the individual doesn't have COVID-19 symptoms.</li> </ul>	MED		✓
Poor management of infectious diseases	Staff Pupils Others	Lack of infection control	<ul style="list-style-type: none"> <li>Staff are instructed to monitor themselves and others and look out for similar symptoms if a pupil or staff member has been sent home with suspected coronavirus.</li> <li>Staff are vigilant and report concerns about their own, a colleague's or a pupil's symptoms to the Headteacher or SLT as soon as possible.</li> <li>The school is consistent in its approach to the management of suspected and confirmed cases of coronavirus.</li> </ul>	MED		✓

			<ul style="list-style-type: none"> <li>• The school is informed by pupils’ parents when pupils return to school after having coronavirus – the school informs the relevant staff.</li> <li>• Staff inform the headteacher when they plan to return to work after having coronavirus.</li> <li>• A nominated person monitors the cleaning standards of school cleaning contractors and discusses any additional measures required with regards to managing the spread of coronavirus.</li> </ul> <p><a href="https://publishing.service.gov.uk">Contingency framework: education and childcare settings (publishing.service.gov.uk)</a></p> <p><b>The thresholds, detailed below, can be used by settings as an indication for when to seek public health advice if they are concerned.</b></p> <p>For most education and childcare settings, whichever of these thresholds is reached first:</p> <ul style="list-style-type: none"> <li>➤ 5 children, pupils, students or staff, who are likely to have mixed closely, test positive for COVID-19 within a 10-day period: or</li> <li>➤ 10% of children, pupils, students or staff who are likely to have mixed closely test positive for COVID-19 within a 10-day period</li> </ul> <ul style="list-style-type: none"> <li>• For special schools, residential settings, and settings that operate with 20 or fewer children, pupils, students and staff at any one time.</li> <li>• All settings should seek public health advice if a pupil, student, child or staff member is admitted to hospital with COVID-19 by phoning the DfE helpline (0800 046 8687, option 1), or in line with other local arrangements. Hospitalisation could indicate increased severity of illness or a new variant of concern. Settings may be offered public health support in managing risk assessments and communicating with staff and parents.</li> <li>• Settings may wish to seek additional public health advice if they are concerned about transmission in the setting.</li> </ul>			
Lack of communication	Staff Pupils Others	Unsafe Practices	<ul style="list-style-type: none"> <li>• The school staff report immediately to the headteacher about any cases of suspected coronavirus, even if they are unsure.</li> <li>• The headteacher contacts the local HPT or follows the advice given from and discusses if any further action needs to be taken.</li> <li>• Schools put into place any actions or precautions advised by their local HPT.</li> <li>• Schools keep staff and parents adequately updated about any changes to infection control procedures as necessary.</li> </ul>	MED		✓

Admitting children into school	Pupils Staff	Infection Control	<ul style="list-style-type: none"> <li>In most cases, parents and carers will agree that a pupil with symptoms should not attend the school, given the potential risk to others. If a parent or carer insists on a pupil attending your school, you can take the decision to refuse the pupil if, in your reasonable judgement, it is necessary to protect other pupils and staff from possible infection with COVID-19.</li> <li>Decisions need to be carefully considered in light of all the circumstances and current public health advice.</li> </ul>	MED		✓
CEV children	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>All CEV children should attend their education setting unless they are one of the very small number of children under paediatric or other specialist care who have been advised by their GP or clinician not to attend.</li> </ul>	MED		✓
Admitting people into school	Pupils Staff	Infection control	<ul style="list-style-type: none"> <li>Pupils, staff and other adults <b>should not</b> come into school if they have symptoms, have had a positive test result or have been instructed to quarantine. <a href="https://www.nhs.uk/conditions/coronavirus-covid-19/symptoms/">https://www.nhs.uk/conditions/coronavirus-covid-19/symptoms/</a></li> <li>Anyone staff or pupils within the school who appear to have COVID-19 symptoms are sent home, advised to avoid using public transport and, wherever possible, be collected by a member of their family or household and to follow public health advice.</li> <li>In the case of a pupil awaiting collection, they should be taken to a room away from other pupils and supervised.</li> <li>If the member of staff is in close contact with the child then they should wear appropriate PPE.</li> <li>Windows should be opened for fresh air ventilation if possible.</li> <li>Any rooms that have been used for this purpose should be cleaned when vacated.</li> <li>As anyone within the household should follow the PHE guidance for households with possible or confirmed COVID-19 infection, siblings within the school will be identified and also sent home.</li> </ul>	MED		✓
